Dear North Bellerose neighbors:

Welcome to phase four. We must remain vigilant and not let down our guard. While we still do not know when community gatherings such as NBCA can resume in person; phase four allows socially distant gathering as large as 50 people; that reguires a much larger space than is often available to us; it remains unclear when the Beacon school will be available. Following the success of our June and July videoconference meetings, we plan another meeting on Wednesday, August 12 that again will start in earnest at 7:30 p.m. but the "doors" will open at 7:00 p.m. To make such no one unwelcome interrupts our meeting (they call it "Zoom-bombing"), NBCA again asks our members to email their requests for the sign-in link and credentials. At our meeting I will report on our efforts as part of the community/civic-based 116th Precinct Task Force. The City Budget removed funding to build a new 116th Precinct so that the extremely large 105th Precinct would be serving only its northern portion including Bellerose. NYCDOT advised DOT's Queens Borough Engineer's Office has upgraded the stop signs at 81st Avenue, 82nd Drive, 83rd Avenue, Hillside Avenue, and Union Turnpike, as well as numerous stop signs that have been defaced with illegal stickers. inspected the "school crossing" sign that was defaced and removed the sign after determining that it was no longer necessary at the existing location. 


