QUEENS, NY –(5/23/2014) Today, the Council of School Supervisors & Administrators (CSA) Local 1: American Federation Of School Administrators, AFL-CIO, the Mason Tenders District Council and the Amalgamated Transit Union Locals 1056 and 1179 endorsed Leroy Comrie for New York State Senate (14th Senatorial District).
